Actions Prior To The Meeting

There are four resolutions to be considered and voted on by the shareholders at the GM. One resolution is proposed as an "Ordinary Resolution", with the remaining three resolutions proposed as "Special Resolutions".

Ordinary Resolutions

Resolution 1 – Allotment of Shares

The purpose of this resolution is to grant the Club's Board of directors (the "Board") the ability to raise up to £4m, by increasing the number of shares in issue up to an aggregate nominal amount of £7,739,916.

Special Resolutions

Resolution 2 – Waiver of Pre-emption Rights

The purpose of this resolution is to grant the Board the ability to issue the New Shares without offering them first to all of the Shareholders of the Club (the "Shareholders"). As a result, all other shareholders will see a small dilution due to the issue of new shares.

Resolutions 3 and 4 – Redesignation of Preference Shares

The purpose of these resolutions is to redesignate preference shares, held by certain major shareholders, as ordinary shares. This will result in a small dilution for existing shareholders.
